Statement of Legal Effect

Clause 2: This clause amends section 4 of the Trust Receipts Ordinance (Chapter 86), and the legal effect of the section as amended is to provide for the legal consequences of trust receipts registered under the Secured Transactions Act, No. of 2023, but not under the Registration of Documents Ordinance (Chapter 117).

Clause 3: This clause makes provisions in regard to the period of enforceability of trust receipts already registered under the Registration of Documents Ordinance and the requirement of registering those trust receipts under the Secured Transactions Act, No. of 2023 upon coming into operation of the said Act in order for them to be further enforceable and for their priority to continue to prevail.

AN ACT TO AMEND THE TRUST RECEIPTS **ORDINANCE (CHAPTER 86)**

BE it enacted by the Parliament of the Democratic Socialist Short title Republic of Sri Lanka as follows: and date of operation

1. (1) This Act may be cited as the Trust Receipts (Amendment) Act, No. of 2023.

- (2) The provisions of this Act, other than the provisions 5 of this section, shall come into operation on such date as the Minister may appoint by Order published in the Gazette (in this Act referred to as the "appointed date").
- (3) The provisions of this section shall come into 10 operation on the date on which the Bill becomes an Act of Parliament.
- 2. Section 4 of the Trust Receipts Ordinance (Chapter 86) is Amendment hereby amended in subsection (1) of that section, by the of section 4 substitution for the words "registered under the Registration" of Chapter of Documents Ordinance as a bill of sale", of the words and figures "registered under the Secured Transactions Act, No. of 2023 as a bill of sale".

3. (1) Where on the appointed date a trust receipt which Provisions has been registered under the Registration of Documents relating to 20 Ordinance (Chapter 117) as a bill of sale is in force, such trust trust receipt shall, for a period of two years from the appointed receipts date, continue to be enforceable, but shall be required to be registered registered under the relevant provisions of the Secured under the Transactions Act, No. of 2023 as a bill of sale, prior to the Registration 25 expiration of such period of two years.

(2) A bill of sale referred to in subsection (1) shall, on Ordinance being registered under the Secured Transactions Act, No. of 2023, be deemed to have been perfected from the date on which such bill of sale initially became legally enforceable, 30 and any priority which such bill of sale became entitled to at the time it initially became legally enforceable, shall continue to prevail.

- (3) A bill of sale referred to in subsection (1) which is not registered under the Secured Transactions Act, No. of 2023 prior to the expiration of two years from the appointed date, shall become legally unenforceable after the expiration of such period.
- 4. In the event of any inconsistency between the Sinhala Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
